CHURCH OR 501(c)(3) ?

As you know, one of the key advantages of being an agency partner with the Food Bank of East Alabama is the access to resources provided through our collaboration with Feeding America. This partnership enables us to maintain vital relationships with national donors which are essential for addressing the hunger in our communities.

To ensure compliance with Feeding America, it is imperative that we partner with eligible organizations only. According to the Food Bank's contract, organizations eligible to receive and distribute donated products must fall into one of the following categories:

- a public charity
- a church

Public charity refers to a nonprofit organization that is tax-exempt under section 501(c)(3) of the Code. When agencies apply for membership with the Food Bank, they are required to provide documentation to verify their eligibility either as a church or tax-exempt nonprofit. If this status is ever revoked, the agency is no longer eligible to be a food bank agency.

Every year, the Food Bank conducts an audit of our agencies that includes verifying the qualifying status. Revoking the agency status is often due to administrative oversight where the necessary tax documentation was not submitted to the IRS for three consecutive years. When we find that an agency no longer has this status, we notify the agency so that the issue can be resolved.
